UNDERTAKING TO BE GIVEN ALONG WITH THE NOMINATION PAPER (FORM 2), DULY SIGNED BY THE CANDIDATE CONCERNED:

UNDERTAKING

1. That for the post of any of the Office Bearers (President/Secretary General/Treasurer), the following undertaking have to be given alongwith the Nomination Form: -

‘THAT I WILL NOT ATTAIN THE AGE OF 70 YEARS ON THE DATE OF ELECTION AND MY DATE OF BIRTH IS DATE/MONTH/YEAR.

(It is mandatory to attach the document in proof of date of birth).

‘THAT I HAVE NOT COMPLETED 5 (FIVE) CONSECUTIVE TERMS OR 20 (TWENTY) YEARS IN ANY OFFICE BEARER POST IN IOA.

‘THAT I HAVE NOT COMPLETED 3 (THREE) CONSECUTIVE TERMS OR 12 (TWELVE) YEARS AS PRESIDENT, IOA.

‘THAT I HAVE NOT COMPLETED 2 (TWO) CONSECUTIVE TERMS OR EIGHT YEARS AS SECRETARY GENERAL / TREASURER, IOA.

2. That for the posts of Office Bearers and the Executive Council Members, the following undertakings have to be given alongwith the Nomination Form: -

‘THAT ON THE DATE OF FILING OF THE NOMINATION, THE UNDERSIGNED HAS NOT BEEN CONVICTED OF ANY OFFENCE OF SERIOUS NATURE UNDER THE INDIAN PENAL CODE/PREVENTION OF CORRUPTION ACT.’

‘THAT NO CHARGES HAVE BEEN FRAMED BY ANY COURT OF LAW IN INDIA IN RESPECT OF THE OFFENCE WHICH IS OF A SERIOUS NATURE UNDER THE INDIAN PENAL CODE AND PREVENTION OF CORRUPTION ACT AND IN WHICH THE PUNISHMENT OF IMPRISONMENT IS OF MORE THAN TWO YEARS’.
