**Re: Legal Notice** regarding the unauthorized use of our client **Indian Olympic**

**Association's Name and Logo**  without their due consent.



**Our Client:** Indian Olympic Association of Olympic Bhawan, B-29, Qutab Institutional Area, New Delhi-110 016 (herein referred to as **IOA**).







Sir/Madam,

We write to you on behalf of and under the instructions of our client, IOA. Any reference to our client shall hereinafter refer to and include its predecessors, subsidiaries, affiliates, licensees and we serve upon you this legal notice as follows-

1. It has come to our client's attention that you, your agents, assignees, representatives, successors, distributors, directors, partners and other entities acting on your behalf are using the name and logo  of our client, the Indian Olympic Association (IOA) in your official letterhead, various official communications, promotional materials, websites, and social media platforms. This is being done despite the clear fact that TFI is not affiliated, recognized, or associated with the IOA in any manner whatsoever.
  
2. Our client, **IOA**, as you are well aware, is an organization registered under Indian Societies Registration Act, 1860. It operates as a non-profit organization and has jurisdiction all over India. It is also acknowledged as the Ultimate and Supreme Authority for Olympic related games in India. In line with the International Olympic Committee's Olympic Charter (hereinafter referred to as the "**Olympic Charter**"), the IOA cultivates, advances, and defends the Olympic movement in India. Our client is an affiliated member of The Olympic Council of Asia (hereinafter referred to as "**OCA**"), the Association of National Olympic Committees (hereinafter referred to as "**ANOC**"), the Commonwealth Games Federation (hereinafter referred to as "**CGF**"), and the International Olympic Committee (hereinafter referred to as "**IOC**").
  
3. Our client, as the sole authority for Olympic related games in India, has been involved with a variety of National Sports Federations, State Olympic Associations, IOC Members, and other multi-sport organizations, as well as the Winter Olympic Games, Asian Games, and Commonwealth Games since their incorporation in 1927. Throughout their business and non-business activities, our client has sincerely developed and created their unique name and logo , which has been widely utilized in connection with the Organization and Sports Events in India, and throughout the world.

4. Our client originally came up with and introduced their logo  in India, used individually or in conjunction with their incorporated name **Indian Olympic Association**, in the trading community.
5. Indian Olympic Association administers various aspects of sports governance and athletes' welfare in the country. In this regard, our client oversees the representation of athletes or teams participating in the Olympic Games, Commonwealth Games, Asian Games and other international multi-sport competitions of the above named IOC, CGF, OCA and ANOC and is recognized by the Ministry of Youth Affairs and Sports. Our client is the proprietor of the logo , which has become a global brand and its use on any product or service would result in an immediate assumption of association with Indian Olympic Association.
6. Our client has made significant efforts and has invested large sums of money in advertising, promoting and marketing in order to popularize their logo . The same has also been advertised in both electronic and printed media, having widespread reach and circulation in India and other parts of the world.
7. Our client, **IOA** has an active website, which can be accessed as under <https://olympic.ind.in/>, wherein its trademark and logo  has been promoted.
8. That the continuous use of the Indian Olympic Association's logo  in various regions of the country, by our client, has established a unique position in the minds of consumers and traders which has made it an exclusive property of our client as well as its parent organization.
9. That the logo  is the exclusive property of the Indian Olympic Association. Pursuant to the fact that you are not affiliated with the Indian Olympic

Association (IOA) in any capacity, you are hereby prohibited from using the logo of the Indian Olympic Association on any uniforms, materials, or any other items, in any manner, without prior written authorization from the IOA. This not only infringes the Intellectual Property Rights of the IOA, but also results in the adulteration and reduction of sponsorship funds and other forms of funding from sponsors and other organizations. This could therefore compromise the operation of the affiliated organizations and impede the efforts of our client towards the development of the athletes and the Olympic Sports.


10. Our client is the legitimate owner of all Intellectual Property and legal rights in and the Olympic Games and Olympic properties, including trademarks, copyrights, device mark of flame and torches, Olympic symbol and rings, flag, the motto, anthem, identifications, designations and emblems along with other such marks as registered by our client in India in compliance with and under the Olympic Charter and The Nairobi Treaty on the Protection of the Olympic Symbol, 1981(hereinafter referred to as the “Nairobi Treaty”).


11. Please be informed that you have used the name and logo  , belonging to our client on your official letterhead as well as promotional materials without the express and written consent of our client, thereby leading to infringement of the rights of our client. It is pertinent to mention herein that if any individual or entity engages in such actions, our client has the authority to take severe measures against such unauthorized and unconsented use of the trademarks of our client. A copy of your invitation to the State Taekwondo Association and the Central Organization on your official letterhead is annexed herewith as **Letter ‘A’** which clearly shows your misuse of our client’s name and logo.


12. Our client has **Proprietary and Statutory Rights** for use of its logo  and IOA’s name, logo, and emblem are protected under applicable laws, including but not limited to the Emblems and Names (Prevention of Improper Use) Act, 1950, the Trade Marks Act, 1999, and relevant provisions of the Copyright Act, 1957. Any unauthorized use or misrepresentation of affiliation with IOA constitutes a


violation of statutory rights and may amount to fraud, misrepresentation, and passing off.

13. Furthermore, you are no longer affiliated with our client, the Indian Olympic Association (IOA), nor with the Government of India or World Taekwondo. Your continued and deliberate misrepresentation of such affiliations amounts to a willful attempt to mislead the public and unlawfully derive benefit from the reputation, goodwill, and global recognition of our client and World Taekwondo. It is evident from the above assertions that you have adopted the name and logo in order to hamper our client's goodwill and reputation. Our client is concerned about this dishonest behavior of yours, which appears to exploit our client's unique intellectual property rights. Our client believes that there is a resemblance to their logo and that the public will be misled into thinking that your organization is affiliated and/or connected to our client. A copy of the letter dated 10th July, 2019, issued by World Taekwondo, withdrawing recognition of the Taekwondo Federation of India (TFI) as the national governing body for Taekwondo and confirming your suspension as a member, is annexed hereto and marked as **Letter 'B'** for your reference.


14. It is pertinent to mention herein that you are not linked and/or connected to our client in any manner whatsoever and as such the adoption of the renowned, well known and registered logo  of our client clearly portrays your mala fide intention to get associated with the Indian Olympic Association resulting in the dilution of the rights of our client and their affiliated entities and/or parties. A copy of the office order issued by IOA has been attached herewith for your reference as **Letter 'C'**.

15. The unauthorized adoption and utilization of our client's reputed name and well known logo  without the express permission and authorization from our client has led to a violation of their Intellectual Property Rights. As such, we ask that

you immediately cease from using the name and logo  of the IOA and take **down all posts** on your social media, *inter alia*, posters, advertisements and any and all online content, through which you may have attempted to get associated with us or use the logo of our client in such unauthorized way. You are also further directed to refrain from using any other logo, which is identical or

deceptively confusing or similar to our client's logo , or any related mark, which might create a confusion in the minds of the consumers about the affiliation and/or connection our client with you. You are falsely representing an affiliation with the Indian Olympic Association (IOA) by using its name and logo without due consent which constitutes a willful attempt to mislead the public and unlawfully exploit the reputation and goodwill of the IOA. For your reference, a copy of the official list of Affiliated Member Sports Federations of the IOA which clearly indicates that the Taekwondo Federation of India is not an affiliated member is annexed hereto and marked as **Letter 'D'** and **'E'** respectively.

16. That our client expects you to provide a written undertaking stating that you recognize our client's name and logo and thus promise not to use, sell, promote, or list the logo in the future as a domain name, trading name or use the same in any other manner which might cause confusion in the minds of the consumers in relation to your association with our client's and / or their trademarks.

17. Our client reserves the right to seek compensation for damages incurred as a result of your unauthorized use of our client's name and logo .

18. This may include legal costs, reputational damage, and any other losses suffered by our client.

19. In the event you fail to comply with the above **within 72 hours** from the receipt of this notice, our client will be constrained to initiate appropriate civil as well as criminal proceedings to protect their rights and interests and such proceedings

will be at your sole risk, cost and consequence. The legal costs associated with this legal notice are an amount of Rs. 20,000/- (Rupees Twenty Thousand Only), which you are required to remit by way of a Cheque / Demand Draft drawn in favour of the **"INDIAN OLYMPIC ASSOCIATION"**.

20. This notice is being issued without prejudice to the rights and remedies available to our client in law.

3. Junior Male & Female Athletes aged between 15 & 17 Years (Born between 01/01/2008 & 31/12/2010) are eligible to participate in both Kyorugi & Poomsae Events. Athletes should be holder of Kukkiwon 1<sup>st</sup> Dan & above Certificate.

4. Senior Male & Female Athletes aged 17 Years & Above (Born on or before 31/12/2008) are eligible in **Kyorugi Events**. Athletes should be holder of Kukkiwon 1<sup>st</sup> Dan & above Certificate.
5. Senior Male & Female Athletes aged 18 Years & Above (Born on or before 31/12/2007) are eligible in **Poomsae Events**. Athlete should be holder of Kukkiwon 1<sup>st</sup> Dan & above Certificate.
6. One athlete can participate in only two events in Poomsae division.

Age will be calculated based on the year 2025. Holder of TFI ID Card & recommended by the President / Secretary of Affiliated State Taekwondo Association / Organization are eligible. We are enclosing the following:-

**Subject:** withdrawal of recognition - TFI as the national governing body of Taekwondo

Dear Mr. Pangotra,

World Taekwondo (hereinafter: WT) has been monitoring the situation in India for the past months. Due to good governance issues and multiple complaints, your federation was preliminary suspended as member of WT on 10 July 2019. Your federation has insufficiently shown to remedy the cause of the preliminary suspension.

As a consequence, WT and the India Olympic Association have been working closely together to find a solution in the best interests of the athletes. Considering all circumstances and recent positive developments and under the authority vested in Article 9.2 of the WT Statutes, our President decided to recognize "**India Taekwondo**" as the sole national governing body of Taekwondo in India and consequently **withdraw** the WT recognition of your federation with immediate effect. Use of WT names or logos are strictly prohibited from this date. This decision of revocation is scheduled to be ratified by the WT Council on 5 December 2019 at its meeting as stipulated in Article 14.4 of our Statutes.

**OFFICE ORDER****PROHIBITION OF UNAUTHORIZED USE OF THE INDIAN OLYMPIC ASSOCIATION  
LOGO AND OLYMPIC RINGS**

1. It has come to our attention that certain non-affiliated associations and organizations are misusing the logo of the Indian Olympic Association (IOA) and the Olympic rings without proper authorization. This practice not only undermines the integrity of the IOA but also violates the established guidelines of the International Olympic Committee (IOC).
2. **Key Points to Note:**
  - (a) **Unauthorized Use:** The IOA logo and the Olympic rings are protected intellectual properties. Any use without prior written consent from the Indian Olympic Association is strictly prohibited.
  - (b) **Legal Consequences:** Unauthorized usage may lead to legal actions as it infringes upon the rights and trademarks of the IOA and the IOC.
  - (c) **Affiliation Requirement:** Only associations that are officially affiliated with the IOA are permitted to use these symbols in their branding, promotional materials, or any other forms of communication.
  - (d) **Reporting Violations:** We urge all members and stakeholders to report any instances of unauthorized use to the IOA immediately. This will help us take necessary actions to protect our brand and uphold the values of the Olympic movement.
  - (e) **Promoting Integrity:** The Olympic symbols represent unity, excellence, and the spirit of sportsmanship. It is imperative that we all work together to maintain the dignity and respect associated with these symbols.
3. We appreciate your cooperation in this matter and encourage all affiliated associations to promote the values of the Olympic movement responsibly and ethically.
