Election of the Executive Committee of the Volleyball Federation of India (VFI)

NOTIFICATION

New Delhi Dated 01.06.2025

Whereas Justice Krishna Bhat, Hon'ble Judge of the High Court of Karnataka, (Retd.) was appointed by the Indian Olympic Association, vide its letter No. IOA/I-26/2023 dated 25th September 2023, Returning Officer for the purpose of conducting the election of the Executive Committee of the Volleyball Federation of India, which is an affiliate member of the Indian Olympic Association (IOA); and

Whereas notification dated 19th January 2024 (Annexure-1) was issued giving different timelines for conducting the election including formation of electoral college for the said election and date of poll was fixed for 17th February 2024; and

Whereas, W.P.(C) 2136/2024, was filed by Shri Amir Singh against Union of India and others before Hon'ble High Court of Delhi and Hon'ble High Court by its order dated 16th February, 2024, stayed further proceedings in the matter; and

Whereas in another W.P.No. 3759 of 2024, Telangana Volleyball Association Vs. Union of India and others, the Hon'ble High Court of Telangana stayed all further proceedings pursuant to the notification dated 19-01-2024 for three weeks, which was continued further by subsequent orders; and

Whereas the Hon'ble High Court of Delhi directed by its order dated 09-05-2025 in W.P.(C) 2136/2024, in the matter of Amir Singh Vs. Union of India & others, directed as follows

"..... (i) The elections for the constitution of a newly elected body of the Volleyball Federation of India, shall be completed within a period of four weeks, from toady. (ii) The election shall be conducted from the stage, from where the election process was stopped, in view of the order dated 16th February, 2024 passed by this Court....."

The Hon'ble High Court of Telangana was also pleased to pass an order dated 28-5-2025 in W.P.No. 3759 of 2024, Telangana Volleyball Association Vs. Union of India and others, in terms of the order dated 9-5-2025 passed in W.P.(C). No. 1938 of 2024 and other connected matter by Hon'ble High Court of Delhi; and



Now, therefore, in pursuance of the aforesaid orders of the Hon'ble Courts, and in consultation and approval of the Returning Officer, it has been decided to complete the pending election process initiated vide notification dated 19.01.2024. 
