### Eligibility

All the Volleyball players are eligible to participate in the said trials valid passport is mandatory to participate. All the participating players must bring the following documents at the time of trials:

- Valid Passport : Original with minimum 6 months validity
- 5 Passport Size Photographs (45mm x 35mm, White Background & 80 Percent Face)

#### **Important Points:**

- Decision of the selection committee will be final.
- The decision of selection committee to take call on interpretation of particular rule at the time of selection trials will be at its sole discretion.
- All the Women (Open Category) participants should bring the passport and their full luggage. The selected Women (Open Category) players will be required to stay as training camp will start immediately after the completion of selection trials i.e from 14<sup>th</sup> May 2025 onwards and soon after the training camp the team will proceed for the 2025 AVC Challenge Cup for Women to be held at Vietnam from 07th June to 14th June 2025.
