## INDIAN OLYMPIC ASSOCIATION

## 1. Short Title \& Definitions

1.1. These Bye-laws shall be called the 'Election Bye-laws' and shall govern the conduct of the election of Office Bearers of the Indian Olympic Association.
1.2. In these Bye-laws, unless the context otherwise requires, -
a) 'category of post' means the post reserved for males or females;
b) 'clause' and 'sub-clause' means the clause and sub-clause of these Bye-laws;
c) 'Constitution' shall mean the Memorandum and Rules and Regulations of the Indian Olympic Association as amended from time to time;
d) 'Executive Members' means members of the Executive Council of the Indian Olympic Association;
e) 'Form' means the Form appended to these Bye-laws;
f) 'IOA' means Indian Olympic Association;
g) 'Post' includes the office of President, Sr. Vice-President, Vice President, Treasurer and Joint Secretary;
h) 'Office Bearers' shall mean and include all the members holding the Executive Council Posts of the Indian Olympic Association;
i) 'Returning Officer' shall mean the independent Election Commissioner as per Rule 5 of these Bye-laws;
j) 'Rule' means the Rules and Regulations of the Indian Olympic Association.
k) 'SOM' shall mean Sportspersons of Outstanding Merit.

1) 'Voting Unit' means the nominated representatives of the entitled National Sports Federations/individual(s) who are eligible to cast their votes in the Indian Olympic Association elections.

## 2. Executive Council

2.1. As per Article 11.1 of the Indian Olympic Association (hereinafter referred to as ' IOA ') Constitution, the Elections of the IOA, shall consist of the following Office Bearers:

- 1(One) President,
- 1(One) Sr. Vice President,
- 1(One) Treasurer,
- 2(Two) Vice Presidents, including one male and one female Vice President,

- 2 (Two) Joint Secretaries, including one male and one female Joint Secretary,
- 6 (Six) Executive Council Members, out of which 2 (Two), one male and one female, shall be from the elected SOMs and
- 2 (Two) representatives, one male and one female, elected by the Athletes' Commission from among its members.
2.2. The Elections to be conducted for the IOA shall be for the following:
a) President
b) Sr. Vice-President
c) Vice-Presidents
d) Treasurer
e) Joint Secretaries
f) Executive Council Members

1 (one)
2(two)
6(six)

## 3. Manner of Election

3.1. Office Bearers of the Executive Council of IOA shall be elected by secret ballot.
3.2. Election shall be held at the Annual / Special General Council Meeting (hereinafter "AGM"/"SGM") in accordance with the procedure prescribed hereinafter, from amongst:
a) The representatives of the National Sports Federations - Affiliated to their respective International Sports Federation whose sport is a part of the Olympic/Asian/Commonwealth programme.
b) Indian Citizens who are members of IOC.
c) Athletes Commission representatives elected by the Athletes Commission.
d) Sportspersons of outstanding merit selected by the Athletes Commission.

## 4. Electoral College for Elections to the Executive Council

4.1. Each person(s) duly affiliated with IOA as its Member as per Article 10 of the IOA Constitution shall have the right to be elected and vote at the elections of the Office Bearers.

4.2. The Voting Unit(s) will forward to the Returning Officer, the names and other details of their nominated representatives in the manner prescribed, at least 20 (twenty) days prior to the holding of the IOA elections. The names of the representatives entitled to vote and the representative as per the rules must be duly signed by both the President and the Secretary General of the concerned Voting Unit. In respect of IOC member(s), SOMs and the representatives of the Athletes Commission, no endorsement from the President/Secretary General, is required.

For unavoidable reasons, a Voting Unit may change their representatives not later than three (3) days before the date of the General Assembly and such change will be duly notified by the Returning Officer immediately by pasting on the notice board or in any manner as may be decided by the Returning Officer. Such change will be authorised only by way of a resolution passed by the Executive Council of the concerned Voting Unit.
4.3. The Returning Officer will notify the list of the Authorised Representatives received by him/her and make it public by pasting the same on the notice board or in any manner as may be decided by him/her, so appointed to conduct the election of the IOA.
4.4. The IOA shall furnish a duly authenticated copy of the last Electoral College to the Returning Officer as soon as the Returning Officer has been appointed.

## 5. Returning Officer cum Election Commissioner

5.1. A Returning Officer who shall be an independent Election Commissioner will be proposed by the Executive Council for ratification by the General Assembly. Such Returning Officer shall conduct and supervise the election process. The Returning Officer (with the reserve/ Commissioner / alternate member in case the nominated member quits/becomes unavailable) must be

- appointed from amongst independent, impartial, and unquestionable personalities,
- must not be candidates from any position,
- must not be voting members and
- must not have any interest in the election process.

5.2. The name and a brief background of the proposed Returning Officer (and of the reserve/alternate member/Commissioner) will be submitted to all the voting Members of the General Assembly for ratification by more than 50 percent Members, within 7 (seven) days of intimation in its AGM/SGM or through an electronic ratification process. In case of an electronic ratification process, if no reply is received within 7 (seven) days, the proposed Returning Officer (and the reserve/alternate member/Commissioner) will mean automatic approval of the concerned Member for ratification of the Returning Officer along with the reserve alternate member.
5.3. The Returning Officer shall have the power to issue decisions/directions for conduct of the election of Office-Bearers of the IOA in respect of any matter not covered under the Memorandum and Rules and Regulations of the IOA and the present bye-laws, which shall be final and binding. All election procedures including preparation, finalization, circulation of the electoral list, accepting of nominations, scrutiny, balloting and counting of the results, verification and announcement of the results shall be conducted by the Election Commissioner.

## 6. Nomination of Candidates

6.1. The nomination of a candidate for election as Office Bearer (except for the representatives of the Athletes Commission) shall be made in Form 2 and only such candidates can contest the election whose name forms a part of the Electoral College.
6.2. Nominations submitted in Form 2 must be duly signed by the candidate as well as the proposer and seconder of such candidate, no later than fifteen (15) days prior to the elective AGM/SGM. The proposer and seconder must also form a part of the Electoral College.
6.3. Each Nomination Paper Shall be delivered to the Returning Officer in person by the candidate himself/herself or by any authorized representative of the candidate. Such authorisation must be in writing duly signed by the candidate.
6.4. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been submitted to the Returning Officer.
6.5. The Returning Officer shall prepare a list of all nominations received by him, post-wise, in Form 3; and publish the same in a conspicuous place in her/his office.
6.6. No person shall be eligible to nominate (either as proposer or seconder) more than one candidate for the same post, and if s/he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall not be accepted.

## 7. Scrutiny of Nominations

7.1. The Returning Officer shall scrutinize each nomination paper, one by one, received by her/him, and

determine its validity or otherwise.
7.2. At the scrutiny of nominations, each candidate or one of his/her authorised representative shall have the right to be present and raise any objection(s) in relation to the nomination for the post for which he/she has filed his/her nomination.
7.3. As soon as may be after the scrutiny of all nomination papers has been completed, the Returning Officer shall prepare a list of validly nominated candidates in Form 4 and display the same at a conspicuous place in the office of the IOA at Olympic Bhavan, B-29, Qutub Institutional Area, New Delhi -110016 and on the IOA website being https:// olympic.ind.in/.

## 8. Withdrawal of candidatures

8.1. Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature within the period/timeline notified by the Returning Officer.
8.2. Notice of withdrawal of candidature shall be submitted in Form 5, either by the candidate himself/herself or by the authorized representative of the candidate.
8.3. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
8.4. The Returning Officer shall accept the notice of withdrawal if $\mathrm{s} / \mathrm{he}$ is satisfied as to the genuineness of the notice.
8.5. As soon as may be after the withdrawal timeline, the Returning Officer shall prepare the final list of contesting candidates in Form 6. The same shall be displayed at a conspicuous place in the office of the IOA at Olympic Bhavan, B-29, Qutub Institutional Area, New Delhi -110016 and on the IOA website beinghttps://olympic.ind.in/. The Returning Officer shall also furnish a copy of the same to each of the candidates/their authorised representatives, if they so demand.
8.6. The names of the contesting candidates in Form 6 shall be arranged, for each post, in alphabetical order according to English alphabets.

## 9. Uncontested Returns; and Contested Elections

9.1. Where the number of contesting candidates for any post or category of post, in Form 6 is equal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such posts.
9.2. Where the number of contesting candidates for any post or category of post, in Form 6 is more than the number of posts to be filled, a poll shall be taken by secret ballot for those posts remaining unfilled.

9.3. The ballot papers for these posts remaining unfilled shall be in Form 7 to Form 12 to be made individually for each post.
9.4. The names of contesting candidates on the ballot papers shall appear in the same order as in Form 6.

## 10. Poll

10.1. The Poll for the posts remaining unfilled under clause 9.2 above shall be taken post-wise and shall commence during the AGM as per the agenda item - Elections.
10.2. Each contesting candidate can nominate one person, (If he/ she so desires), only from amongst the Electoral College, to be present at the Polling station.
10.3. At the poll, each authorised representative of Voting Units, whose name is included in the Electoral College list in Form 1, shall be entitled to -
a) cast one vote for each of the posts remaining unfilled, where only one such seat is to be filled
b) cast as many votes as are the no. of seats to be filled for any post, where more than one seat is to be filled.

Explanation: It is hereby clarified that for the purpose of filling two seats of Vice-Presidents, each voter can cast up to 2 (two) votes, and, likewise, for six seats of Members of Executive Council.
10.4. In case any voter casts his/her vote for more than one candidate, or for more than two or six candidates, as the case may be, then his/her vote for that post shall be invalid.
10.5. Each voter shall be required, before $s /$ he is supplied with a Ballot paper, to give her/his signature on the authenticated copy of the Electoral College list in Form 1 used by the Returning Officer for taking the poll.
10.6. The voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose, at the polling station.
10.7. The voter shall record his/her vote on the ballot paper by placing a tick mark $(\checkmark)$ against the name of the candidate of his/her choice. Any other mark, like (x) or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.
10.8. The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.
10.9. The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.

10.10. After all the voters referred to in sub-clause (9) have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.
10.11. Polling will be done in the below order:
(1) President
(2) Sr. Vice President
(3) Vice Presidents
(4) Treasurer
(5) Joint-Secretaries
(6) Executive Members (including SOMs).

## 11. Counting of Votes

11.1. The Returning Officer shall take up the counting of votes as soon as may be after the polling is complete.
11.2. Each contesting candidate can nominate one authorised representative (as clarified in S. No. 10.2) and he/she shall be entitled to be present at the place of counting of votes.
11.3. The Returning Officer shall take up the counting of votes, post-wise.
11.4. Each ballot paper on which a vote has been recorded in accordance with sub-clauses (3) to (8) of clause (10) shall be treated as one vote for the candidate for whom it has been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions of sub-clauses (3) to (8) of clause (10) shall be rejected by the Returning Officer.
11.5. The votes validly cast for each of the contesting candidates shall be counted post-wise and recorded in the descending order of the votes so cast for each candidate in Form 13.
11.6. The Returning Officer shall thereafter ascertain the result of counting and, for the posts where only one seat is to be filled, the candidate who has secured more than $50 \%$ of the votes validly cast by the members present and voting in the election shall be declared elected. If none of the candidates for a specific position obtains more than $50 \%$ of the votes validly cast, a second round shall be organised between the two candidates who have obtained the highest number of votes validly cast in the first round. The candidate obtaining more than $50 \%$ of the votes validly cast in the second round shall be declared elected.
11.7. For the posts where more than one seat is to be filled, the same rationale of more than $50 \%$ of the votes validly cast by the members present and voting in the election, as provided in Rule 11.6 hereinabove, shall be adopted. Therefore, each seat of such posts shall be treated as a separate post and separate ballot boxes shall be prepared by the Returning Officer. The name of the candidate/(s) who has/have already been declared elected in one ballot box for such posts, shall be deleted from the remaining boxes for the purposes of counting the votes. If required, a second

round of voting may be conducted by the Returning Officer, wherever the stipulations of Rule 11.6 have not been met, i.e., obtaining more than $50 \%$ of the votes validly cast.
11.8. In case of tie of votes for a particular post, the tie shall be resolved through a draw of lots by the Returning Officer.

## 12. Declaration of Results

12.1. The Returning Officer shall declare the names of the duly elected candidates in Form 14. The same shall be made publicly available on the website of the IOA.
