# UPON hearing the counsel the Court made the following O R D E R $\,$

- Justice L Nageswara Rao, former Judge of this Court, has submitted a note dated 2 November 2022. The note indicates the comprehensive exercise which has been carried out by the learned former Judge of this Court on an expedited basis. The Court appreciates the alacrity with which the assignment has been taken up in the national interest. The learned Judge has interacted with all stake holders including the International Olympic Committee, Indian Olympic Association (IOA) and the State Associations.
- 2 The amendments proposed to the constitution of the Indian Olympic Association have to be circulated today so that the General Body Meeting can be held on 10 November 2022. The proposal which has been submitted in that regard is accepted. The proposed amendments are permitted to be circulated. Justice L Nageswara Rao is at liberty to chalk out the modalities for the circulation of the proposed amendments.
- There is a broad consensus in terms of the note submitted by Justice L Nageswara Rao that the elections should be held on 10 December 2022. The proposal is accepted. The proposed election schedule is extracted below:

#### NOTE:

The timeline has been made as per the schedule provided under the IOA Constitution read with the Model Guidelines for Elections under the Sports Code, 2011.

- Clause 9: AGM 30 clear days notice; SGM 15 clear days notice;
- Clause 9.1: Notification for the meetings may be sent by letter or by e-mail/Speed Post/Courier
  as considered expedient and be also posted on the IOA website.
- Clause 10.4 The voting units will forward to the IOA the names of their representative(s) entitled
  to attend and vote at the Elective General Meeting of the IOA at least 20 days prior to the holding
  of the General Meeting.
- Clause 11.2 Election Procedure: The procedure for the election of the members of the Executive Council shall be as indicated in Bye-law 1 to the Rules and nominations forms along with notice of the meeting shall be sent to all voting members of the IOA not later than 30 days before the elections.
- Clause 12.7 An Independent Election Commissioner / Returning Officer will be nominated by
  the Executive Council. The name and a brief background of the proposed Election Commissioner
  will be submitted to all the voting Members for ratification within 7 days of intimation by more
  than 50 percent members of the General Council in its meeting or through an electronic
  ratification process.
- Clause 19 Amendment of rules and regulations: All proposed amendments must be presented to the Secretary General at the latest a week before the meeting, and forwarded by him to every Member.
- 4 No other court shall entertain any petition relating to the amendment of the constitution of the IOA or to the election to the Executive Committee of the IOA. All objections shall be submitted by any person or party before this Court alone.
- The learned Solicitor General has stated that Justice L Nageswara Rao has indicated that he would perform the task which has been assigned by this Court *pro bono*. The Solicitor General fairly states that having regard to the magnitude of the task and the efforts which have been put in, it would be appropriate if an honorarium is paid to the learned Judge. Counsel appearing on behalf of the IOA has joined the Solicitor General and submitted that IOA

would bear the honorarium. Subject to Justice L Nageswara Rao accepting the request, an amount of Rs 20 lakhs may be paid to Justice L Nageswara Rao towards the honorarium.

- The Court has also been apprised of the fact that having regard to the complexity and the nature of the task, a team of lawyers has assisted Justice L Nageswara Rao. The renumeration which is payable to the assisting counsel shall be fixed by the learned Judge and intimated to IOA. IOA has agreed to defray the remuneration as so fixed.
