## **Proceedings:**

At the outset Chairman of the Ad hoc Committee for Boxing Federation of India welcomed all the Members present in the Meeting. He also thanked Dr PT Usha, President IOA for nominating the Adhoc committee for the Boxing Federation of India. We recognize the challenge ahead and are committed to meeting the expectations of the President of the Indian Olympic Association by ensuring free and fair elections of Federation within the shortest span of time. Together, we will work diligently to uphold the integrity of the sport and foster a positive environment for all athletes.

The Chairman also expressed that the Committee's work will be ATHLETE CENTRIC, and they will be kept above all actions. He also mentioned that the Committee will work in timely manner so that the Athletes should not suffer, and the elections happen within next 2 months.

Chairman mentioned the agenda to be discussed, and the decisions taken thereof are as follows;

• It was discussed that the Ad hoc Committee has already taken Charge today itself and the final handover of documents and other items will take place on 27<sup>th</sup> February 2025 as 26<sup>th</sup> February being Holiday.

- It was decided that all the state Boxing associations will be directed to send documents at earliest to proceed with the elections of BFI (The List of required documents will be sent separately).
- The committee unanimously agreed to direct all previous principal office bearers and subcommittees that their powers have ceased with immediate effect. A notice of this effect should be sent to the Previous Principal Office Bearers today itself.
- It was also decided that the BFI paid staff should be directed by Earlier Principal office bearers to report with all the important documents to report the new camp office (Office address to be communicated soon) from 27<sup>th</sup> February 11.30 AM.
- A formal request will be sent to the President of the Indian Olympic Association (IOA) to provide a camp office at IOA Bhawan for the Ad hoc Committee's operations.
- The committee decided to organize a physical meeting with all affiliated state sports associations during the first week of March 2025 to discuss future strategies and collaboration
- It was emphasized that national events must be organized as required and athletes do not suffer due to any administrative issues and if required trial should be conducted for any future international events and ex elite boxers may be requested to make a formidable selection committee till the elections are held.
- The committee will ensure that transparent and fair elections for the Boxing Federation of India are conducted within the next two months, post validation of State Associations if required. But at any cost the elections should be held by April end. (2025)
- A request will be made to the old office bearers of the BFI to cooperate with the Adhoc Committee in efforts to restore the glory of boxing in India.
