FORMATION OF LEGAL COMMITTEE

This is to formally notify that, in pursuance of the objectives set forth by the Steering Committee, a **Legal Committee** hereby duly constituted to provide legal guidance and support to the Steering Committee and VFI on matters related to governance, compliance, constitutional matters, dispute resolution, regulatory obligations, contracts, and any other legal affairs concerning the federation.

The committee shall work closely with the Steering Committee and submit recommendations, legal opinions, and necessary documentation whenever required for the smooth functioning and transparency of VFI operations. The following are the major tasks to be accomplished by the Legal Committee.

- Amendments in the Constitution of the Volleyball Federation of India
- Amendments in the Constitutions of the State Volleyball Associations
- Recognition and grant of affiliations to hitherto unaffiliated State Associations
- Formation of the Electoral Colleges for VFI elections
- Conduct of Elections of State Associations
- Conduct of Elections of the Athletes' Commission
- Conduct of Elections of the Volleyball Federation of India

The following **three (03) legal expert** shall serve as the **MEMBERS** of the Legal Committee.

1. Mr. Nandan Kamath, Advocate
2. Mr. Vishakh Ranjit, Advocate
3. Mr. Jayvardhan Kandpal, Advocate

Additionally, the Non-Members, Ms. Kumudavalli Seetharaman, Advocate as **CONVENER** and Mr. Abid Siddiqui, Advocate as **COORDINATOR** shall assist the committee to achieve the assignment.

The Legal Committee shall be vested with comprehensive responsibilities to accomplish each of the aforementioned tasks within such timelines as shall be communicated by the Steering Committee from time to time.

- A copy of their Constitution
- Minutes of the last 3 years elections conducted along with the Executive Committee list.
- If any dispute pending before any adjudicating agency, please share a synopsis.
