SUBJECT: PARTICIPATION OF NATIONAL BEACH VOLLEYBALL TEAMS IN CAVA BEACH TOUR 2026, THIMPHU, BHUTAN, AND INVITATION FOR EXPRESSION OF INTEREST TO CONDUCT COACHING CAMP AND ASSIST IN SPONSORSHIP ACQUISITION

The Steering Committee of the Volleyball Federation of India hereby announces the participation of the national beach volleyball teams (men and women) in the upcoming CAVA Beach Tour 2026, to be held from 4 to 6 September 2026 at Thimphu, Bhutan. The participation shall be subject to the availability of sponsorship and no cost to the Steering Committee VFI or the Sports Authority of India.

Team selection will be based on the medal winners of the last National Beach Volleyball Championship, held from 9-12 March 2026 at Marina Beach, Pondicherry.

The Steering Committee further invites Expressions of Interest (EOI) from organizations/associations interested in:

1. Conducting a coaching camp for the national teams (2 teams of each gender), bearing all associated expenses; and
2. Assisting in arranging funds/sponsorship to support the teams' participation in the tour.

Interested organization/association are required to furnish details regarding number of available FOP, number of qualified coaches, accommodation and food arrangements.

The last date for submission of the EOI is **6th August 2026**. The invitation from the Bhutan Volleyball Federation, along with logistical, financial, and technical details, is enclosed herewith for reference.

Visa and Airfare

- All participants are responsible for their international and domestic airfare, airport taxes, visa fees, insurance and other related expenses
- Participants are requested to apply for visas at the earliest possible to ensure timely processing
- The organizers will provide invitation letters and any required supporting documents for processing visa applications upon request

Financial Conditions

1. Expenses to be covered by participating teams

- 1.1. International airfare (round trip) In Bhutan-Paro International Airport (PBH)
- 1.2. A contribution of **US\$ 60** per person per day as partial payment for accommodation and full board. Payment should be made to the Organizer during the Preliminary Inquiry or via bank and transfer prior to team arrival.
- 1.3. Full payment of accommodation with full board for additional members:
 - US\$ 150 per day (single occupancy)
 - US\$ 200 per day (double occupancy)
- 1.4. Any excess baggage charges
- 1.5. Any additional expenses not specifically covered by the Organizer
- 1.6. Airport transfers will be provided for the official team delegations. If delegates travel separately, transportation arrangements shall be the responsibility of the respective team, although assistance may be provided by the Organizer upon request

2. Expenses to be covered by the Organizer

- 2.1. Accommodation and full board for official participating teams
- 2.2. Accommodation and full board (Single Occupancy) for members of the CAVA Control Committee, referees and other CAVA officials
- 2.3. Local transportation includes airport transfers between Paro International Airport and the official hotel, as well as transportation during the event.
- 2.4. Medical first-aid services during the competition.
- 2.5. Arrangement of demonstrative teams and personnel for theoretical and practical refereeing clinics in accordance with the competition schedule.
- 2.6. Economy - class airfare for the Technical Delegate, Referee Delegate and Neutral Referee to and from Paro.
- 2.7. A per diem of US\$ 30 per day for the Technical Delegate, Referee Delegate, and Neutral Referee from arrival until the end of competition.
- 2.8. If the Referee Delegate is nominated by AVC, a per diem of US\$ 80 per day will be provided.
- 2.9. A per diem of US\$ 30 per day per Referee (from arrival until the end of competition).
- 2.10. Any other expenses approved by CAVA.
